- Owned domain expertise for wealth management and financial products, resolving complex business-regulatory-technical trade-offs and unblocking product decisions that enabled timely delivery of compliant platform features.
- Overhauled Evoaq's portfolio optimizer from methodology to UX, by simplifying common use-cases, which ended up massively increasing adoption and adding additional 2M ARR.
- Owned the company's regulatory watch (e.g., LSFIn, MiFID II, ...), mapping new changes to actual required changes across the platforms, and dispatching them to relevant product teams.
- Run a multi-module multi-team roadmap which balanced solving client problems and technical advances, resulting in low technical debt and timely bug fixes.
